Client Challenges



Surface Land taxes for clients owning large, geographically diverse fee land represent significant financial commitment.



Often no centralized system with payments made from local operations.



Standardized business processes around assessment or tax objections are lacking.



Monitoring annual changes to assessed values and tax amounts is cumbersome.



Clients potentially missing out on significant cost savings.



Clients are paying tax on fee property that they don't own.



Landfolio Solution



Create a Parcel Register of all owned Fee Land.



Build mechanism for ingesting assessed values and tax obligations onto the individual parcels.



Create Property Tax Groups reflecting Payee / Payor combinations.

Create custom reports to identify assessed values or tax obligation increases above a specific threshold.

Relate the Parcels to the Property Tax Groups.



Build workflows to manage the receipt of the assessment and tax notices, and the objection process.



Landfolio Solution



Configure business rules that manage the unique date rules of the States/Provinces and Counties/Municipalities/Districts where taxes are paid.



Populate the Tax Payment actions on the Property Tax Groups.



Build automated notifications and distributed reports.



Synchronize with the Corporate Accounts Payable System



Landfolio API and SDK

A fully-featured set of development tools for interacting with Landfolio objects, conforming to validation rules and triggering workflow updates.

Landfolio Webhooks Service

An event-based notification service that follows a publisher-subscriber model to send REST, SOAP or MSMQ messages based on the Landfolio audit log.

Other services

ERP systems, financial systems, enterprise service bus, data update services, content management systems, etc.
