## **History of Mining Licensing in Mozambique**

#### **BEFORE 2003**

#### • FULL MANUAL PROCESS

- Hard copy topographical maps, 1/50 000 & 1/250 000 maps,
- Hand designed license contours
- Low computer processing,
- No live maps,
- Only physical archives management

#### **Related problems**

- Numbering system duplicated on different licenses type,
- Same license type duplicated in the different map scale,
- Hard topographic copy destroyed,
- Hand map matching during drawing...
- Maputo office reception as a reference date and time.
- Areas with no topographic Maps
- TRANSPARENCY NOT GUARANTEED





#### 1998-2003 – Period of Main Change

1998 - Approved new Mining and Geological policy.

#### **OBJECTIVES**

- 1. Increase mining production,
- 2. Increase mineral exportation,
- 3. Increase geological data and investigation, and
- 4. Develop a modern government institution.





## 2002 - Approved new Mining Law focused on the new mining policy.

- 1. Avoid number duplication,
- 2. Provincial offices as entering points,
- 3. One national book entry registration,
- 4. Reduce the time of processing,
- 5. Less hand hard copy map use, and
- 6. Increase the transparency on mining licensing,
- 7. FIRST TO COME FIRST SERVED...





## How to achieve the objectives and implement the Law?


- Update the existing geological information,

- Update the equipment and infrastructure,
- Create attractive investment environment trough the legislation, and
- Update the mining licensing methodology and procedures

- Overlap reduced to zero,
- Unique licensing procedure and methodology,
- Live public information at Maputo office- present stage,
- Reduced time for application and registration,
- Infrastructure and equipment upgraded,
- Human resources allocated and trained
- Increased the number of licenses from 500 in 2003 to 1200 in 2010.





## Main Objectives for Upgrade

- Configure FlexiCadastre focused on the commodities,
- Include all existing licenses and permits,
- Go only for one page Flexicadastre,
- Go for one server office for the country,
- Train a new staff contracted in mining cadastre office,
- Configure the provincial offices for local use and licensing,
- More capabilities ....





#### Major Advantages of new FlexiCadastre

- Integrated *Mapping Interface* using ArcGIS Server
- Customisable Workflow & Business Rules no longer hard-coded
- *Authorisations* User Groups
- Email *Notifications*
- Smart Actions shape changes and validations
- Letter Templates no longer hard-coded
- Complete and transparent *Audit History*
- Ability to connect to **Provincial Offices**
- Ability to receive enhancements & improvements to core FlexiCadastre via standard service packs
- Portuguese Language Pack can be updated with future service packs.

### **Outstanding Issues**

- Connection from Maputo to Provinces to be improved,
- Local Network in the Provinces to be improved,
- User training required for all users in Maputo and provincial offices,
- Data quality issued need to be addressed prior to go-live
- Additional hardware required (computers, scanners etc) to enable provinces to take advantage of new system.
- System configuration needs to accommodate future mining law changes
- Portuguese language pack needs to be reviewed for local Mozambique variations
